



FALL 2012 BENCHMARKING SURVEY RESULTS



In association with Interactive Data Partners (IDP), MISBO and SAIS joined forces to deploy an annual benchmarking survey to member schools. Participating schools have access to the full array of data available and have the ability to filter on select criteria (enrollment, population density, grade levels, state, etc.) and create benchmarking groups with as few as six schools.

Below are selected data points and key ratios. Unless otherwise stated, averages are means.
